**A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF THE TOWNSHIP OF CHELTENHAM, MONTGOMERY
COUNTY, PENNSYLVANIA AUTHORIZING THE
TOWNSHIP MANAGER TO EXECUTE AN AGREEMENT
WITH THE PENNSYLVANIA DEPARTMENT OF
TRANSPORTATION AGREEING TO MAINTAIN AND
OPERATE PEDESTRIAN LIGHTS INSTALLED ON THE
LIMEKILN PIKE BRIDGE OVER SEPTA**

WHEREAS, the Township of Cheltenham, Montgomery County, Pennsylvania (“Cheltenham Township”) has requested that the Pennsylvania Department of Transportation (“PennDOT”) install decorative pedestrian lights on the Limekiln Pike Bridge over SEPTA that is being replaced; and

WHEREAS, PennDOT has agreed to install the lights at the time of replacement with the condition that Cheltenham Township agree to maintain and operate said lights; and

WHEREAS, the Cheltenham Township Board of Commissioners is required to adopt a resolution authorizing the Township Manager to execute an Agreement between Cheltenham Township and PennDOT agreeing to maintain and operate the lights on the Limekiln Pike Bridge over SEPTA, and the Assistant Township Manager be authorized and directed to attest his/her signature.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Township of Cheltenham, Montgomery County, Commonwealth of Pennsylvania that the Township Manager of Cheltenham Township is hereby authorized and directed to sign and execute all amendments, agreements and documents necessary with respect to the operation and maintenance of pedestrian lights on the Limekiln Pike Bridge over SEPTA, and the Assistant Township Manager is authorized to attest his/her signature.


