**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF  
CHELTENHAM TOWNSHIP, MONTGOMERY COUNTY,  
PENNSYLVANIA, ENSURING THE UNDISTURBED USE OF  
THE ELKINS PARK FREE LIBRARY FOR THE LESSER  
PERIOD OF FIFTY (50) YEARS OR THE USEFUL LIFE OF THE  
PROJECT ASSOCIATED WITH GRANT FUNDS WHICH MAY  
BE OBTAINED FROM THE PENNSYLVANIA DEPARTMENT  
OF EDUCATION’S KEYSTONE RECREATION, PARK AND  
CONSERVATION FUND**

**WHEREAS**, Cheltenham Township (“Township”) and the Cheltenham Township Library System (“Library”) in the process of submitting a grant application to the Pennsylvania Department of Education under its Keystone Recreation, Park and Conservation Fund for a roof replacement and HVAC system support repairs at the Elkins Park Free Library located at 563 East Church Road, Elkins Park, PA 19027 (“Facility”); and

**WHEREAS**, the Facility is owned by Cheltenham Township; and

**WHEREAS**, as a condition to obtaining the grant from the Department of Education, Cheltenham Township – as owner of the Facility where the resulting grant funds will be utilized for Library purposes – is required to ensure that the Library will have the undisturbed use and possession of the Facility as a public library for a period of the lesser of fifty (50) years or the useful life of the project to be funded; and


**NOW, THEREFORE, BE IT RESOLVED** that the Board of Commissioners of Cheltenham Township, Montgomery County Pennsylvania, ensures that the Cheltenham Township Library System will have the undisturbed use and possession of the Elkins Park Free Library as a public library for a period of the lesser of fifty (50) years or the useful life of the project to be funded by the Pennsylvania Department of Education’s Keystone Recreation, Park and Conservation Fund.
