A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CHELTENHAM TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA, AUTHORIZING TOWNSHIP ADMINISTRATION TO PURSUE A GRANT UNDER THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT'S KEYSTONE COMMUNITIES PROGRAM TO PROVIDE FUNDING FOR IMPROVEMENTS TO WOODEN PLAY STRUCTURE AT WALL PARK

WHEREAS, the Township of Cheltenham, Montgomery County, desires to apply for funding from the Pennsylvania Department of Community and Economic Development (DCED)'s Keystone Communities Program to provide funding for improvements to the wooden play structure at Wall Park; and

WHEREAS, the wooden play structure is iconic and much-loved by the community; and

WHEREAS, recent evaluations of the playground have determined that sections of the playground have deteriorated and are in need of repair and updated in order to meet safety standards and ensure the play structure will be preserved for continued use by children of Cheltenham; and

WHEREAS, Cheltenham Township agrees to contribute funding above the amount of the \$25,000 limit for this grant; and

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners of Cheltenham Township, Montgomery County, Pennsylvania, hereby authorizes the Township Manager and his/or designee(s) to submit a grant application under the Keystone Communities Program in the amount of \$25,000 from the Department of Community and Economic Development to be used to make improvements to the wooden play structure at Wall Park.

BE IT FURTHER RESOLVED, that the Board of Commissioners of Cheltenham Township, Montgomery County does hereby designate the President of the Board of Commissioners and the Township Manager/Secretary as the officials to execute all documents and agreements between Cheltenham Township and the Department of Community and Economic Development to facilitate and assist in obtaining and administering the requested grant.

BE IT FURTHER RESOLVED that the Township of Cheltenham commits to funding its local share of the project costs that exceed the \$25,000 grant amount.


