Set-Up: All labor is the responsibility of the seller. Cheltenham Township staff will not be available to provide set-up assistance. Each vendor must stay within the designated space assignment. No electricity will be provided. Set-up is from 8:30 am - 9:45 am.

Hours of Operation: The flea market will run from 10 am - 2 pm. No cars will be allowed to drive through after 9:45 am or before 2 pm.

Clean-Up: All clean-up is the responsibility of the vendor. No items or trash may be left behind. If anything is left in your designated area you will be subject to a fine up to \$50.00. Clean-up is from 1 pm - 2 pm.

Tents, Tables & Space: You will be given a 10' x 10' space as your designated selling space. All cars must be parked in the assigned parking areas for the flea market. Remember, no cars will be allowed to drive through the flea market from 9:45 am - 2 pm. You may bring your own 10' x 10' pop up tent if you would like. You are responsible for providing your own tables and chairs. Your tent, tables and chairs must fit in your designated space. No tables will be available to rent.

Food, Beverage & Fundraising: The sale of any food or beverage is not permitted. No fundraising is allowed unless proper approval has been granted.

Alcoholic Beverages & Tobacco: No alcohol or tobacco products are allowed to be sold or consumed.

Trademarked/Counterfeit Merchandise: The sale, display or distribution of merchandise that infringes upon copyrighted design or materials or bears counterfeit trademarks is prohibited.

Other Restrictions: No commercial sales or fundraising will be allowed. This includes, but is not limited to Avon, Tupperware, etc. No firearms, ammunition, martial arts weapons, drugs, drug paraphernalia, over the counter medication, raffles or lotteries may be sold.

Handmade/Craft Sales: The sale of handmade and craft items are permitted, however permission must be given by Township.

Sound: Please keep all sound emitting merchandise to a minimum. Be courteous to your neighbor. You may be asked to turn something off or down if it is causing a distraction.

Animals: No animals are allowed to be sold or given away.

Vendor Limit: This activity will only take place with the minimum of 20 vendors.

Refunds: In the event of inclement weather, refunds will be issued. Please contact the Parks and Recreation Office at 215-887-6200, ext# 227.
