

The regular meeting of the **PUBLIC SAFETY COMMITTEE** for August 2019 was held tonight, Chairman Brockington, presiding. Members present were Commissioners Pransky, Rappoport, Sharkey and Mr. Zygmund-Felt and Ex-Officio member Norris. Commissioner Holland was not present.

Staff present were Bryan T. Havir, Township Manager; Alyson Elliott, Assistant Township Manager; John Weed, Deputy Chief of Police; Joseph O'Neill, Fire Marshal. A Public Attendance List is attached.

Mr. Brockington called the meeting of the Public Safety Committee to order at 10:20 p.m.

1. **Report of the Police Chief**

- A. Deputy Chief Weed reviewed the Police Clearance and Juvenile Clearance Reports for the month of June 2019.

Mr. Norris and Deputy Chief Weed reminded residents to be vigilant in locking their vehicles and keeping items out of sight or, preferably, not leaving them in their vehicles.

Ms. Rappoport requested speed enforcement or traffic calming measures at Glenside Avenue into Cheltenham Hills Drive, Rices Mill Road and Hewett Road and Greenwood Avenue from Glenside Avenue to Church Road.

Mr. Brockington inquired about arrests in the Rowland Park area of the Township with regard to Theft from Autos. Deputy Chief Weed stated there have been arrests; however, thefts continue. They are a crime of opportunity and residents should lock their vehicles and not leave important items in their vehicles. He said that Chief Frye added extra patrols to the east side due to the rise in Theft from Autos.

Mr. Brockington and Deputy Chief Weed discussed the speeding issue on Laurel Avenue. They both look forward to the results of the upcoming Traffic Calming Study. Electronic speed signs will be deployed on Laurel Avenue to remind motorists of their speed.

Mr. Brockington inquired whether the school district had reached out regarding signs for "Schools Back in Session." Deputy Chief Weed stated the Police Department will post the speed trailer by Cheltenham High School to remind motorists and students of their speed.

Upon the motion of Mr. Brockington, the Committee unanimously received the Report of the Chief of Police.

2. **Report of the Fire Marshal**

Mr. O'Neill reviewed the Fire Marshal's report for the month of May 2019, as well as the Fire Board Minutes from the June 6, 2019 Fire Board meeting.

The Committee reviewed the EMS report for the month of May 2019.

Upon motion of Mr. Brockington, the Committee unanimously received the Report of the Emergency Medical Services.

The Committee reviewed the Emergency Management report for the month of June 2019.

Upon motion of Mr. Brockington, the Committee unanimously received the Report of the Emergency Management Coordinator.

Reisinger, Inc., of West Chester, PA to remove and replace two sets of stringers leading to the second floor of the Gottschalk Fire Training Building.

There being no further business, upon motion of Mr. Pransky, and unanimously approved by the Committee, the meeting was adjourned at 10:35 p.m.



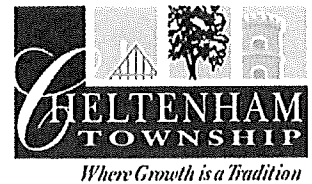

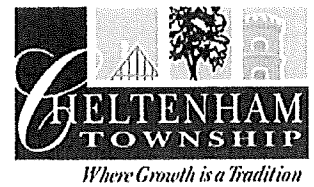

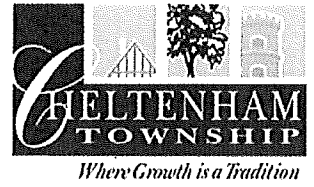
