**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CHELTENHAM TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA SCHEDULING A PUBLIC HEARING TO HEAR PUBLIC COMMENT AND CONSIDER THE ADOPTION OF AN ORDINANCE AMENDING CHAPTER 295, "ZONING," ARTICLE XVII, "C3 COMMERCIAL AND BUSINESS DISTRICTS," TO PERMIT MEDICAL MARIJUANA DISPENSARIES IN CERTAIN PORTIONS OF THE ZONING DISTRICT BY SPECIAL EXCEPTION WHEN CERTAIN CRITERIA ARE MET**

**WHEREAS**, the Township of Cheltenham, Montgomery County, Pennsylvania desires to amend Chapter 295, Zoning, of the Township Code of Ordinances, to amend Article XVII, C3 Commercial and Business Districts, to permit medical marijuana dispensaries in certain portions of the zoning district by special exception when certain criteria are met; and

**WHEREAS**, the Pennsylvania Municipalities Planning Code (MPC) requires municipalities to hold a Public Hearing in accordance with public notice prior to the consideration and adoption of an amendment to the Township's Zoning Ordinance to consider comment, both written and oral, by the public; and

**WHEREAS**, a Public Hearing has been scheduled for October 18, 2017, at 7:30 p.m. at Curtis Hall, 1250 West Church Road, Wyncote, PA, to consider public comment on this Ordinance.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of Cheltenham, Montgomery County, Commonwealth of Pennsylvania that the Township Administration is authorized to advertise a Public Hearing for Wednesday, October 18, 2017, at 7:30 p.m. (prevailing time) at Curtis Hall, 1250 West Church Road, Wyncote, Pennsylvania, 19095 to consider and possibly vote to adopt an ordinance amending Chapter 295, Zoning, Article XVII, C3 Commercial and Business Districts, of the Township Code of Ordinances, to permit medical marijuana dispensaries in certain portions of the zoning district by special exception when certain criteria are met.

**BE IT FURTHER RESOLVED** that the advertisement shall appear in the *Times Chronicle* on Sunday, October 1, 2017, and Sunday, October 8, 2017.


