**RESOLUTION OF THE BOARD OF COMMISSIONERS OF
CHELLENHAM TOWNSHIP, MONTGOMERY COUNTY,
PENNSYLVANIA AMENDING THE FEE SCHEDULE OF
CHELLENHAM TOWNSHIP TO INCREASE THE
EMERGENCY MEDICAL SERVICES FEES FOR BASIC
LIFE SUPPORT AND ADVANCE LIFE SUPPORT (1 AND
2) EMERGENCY TRANSPORTATION SERVICES**

BE IT RESOLVED, and it is hereby resolved this 27th day of September, A.D. 2017 by the Board of Commissioners of Cheltenham Township that:

WHEREAS, Cheltenham Township desires the emergency transportation service fees it charges individuals for Basic Life Support (BLS) and Advanced Life Support 1 and 2 (ALS-1 and ALS-2) emergency transportation services to be at or near the median fees charged by similarly-sized and staffed emergency transportation services in the area; and

WHEREAS, a study performed by Cheltenham Township's Emergency Medical Services personnel found Cheltenham Township's rates to be 14-33% below average; and

WHEREAS, the Cheltenham Township Board of Commissioners has determined it to be in the best interest of the Township to increase BLS, ALS-1 and ALS-2 emergency transportation service fees; and

WHEREAS, Cheltenham Township has the right to fix fees pursuant to Chapter A300 of the Cheltenham Township Code.

NOW THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Cheltenham Township, Montgomery County, Pennsylvania that it deems that it is in the best interest of the Township and its citizens to amend the Township fee schedule effective immediately upon adoption of this resolution as follows by adding the following section:

§A300-28.G. Emergency Medical Services.

- (1) Basic Life Support (BLS) – \$1,150 per call.
- (2) Advanced Life Support 1 (ALS-1) – \$1,375 per call.
- (3) Advanced Life Support 2 (ALS-2) – \$1,680 per call


