**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF  
CHELTENHAM TOWNSHIP, MONTGOMERY COUNTY,  
PENNSYLVANIA AUTHORIZING THE FILING OF A GRANT  
APPLICATION FOR THE FY 2018 COMMUNITY  
DEVELOPMENT BLOCK GRANT PROGRAM FOR THE  
PURPOSE OF REMOVING AND REPLACING STREET TREES,  
UPDATING ADA RAMPS AT THE INTERSECTION OF EUSTON  
ROAD AND CHELSEA ROAD, AND SELECT REPAIR AND  
REPLACEMENT OF CURB AND SIDEWALK ON EUSTON  
ROAD IN LA MOTT**

**WHEREAS**, the Montgomery County Department of Housing Services has been allocated monies by the U.S. Department of Housing and Urban Development (HUD) for its Fiscal Year 2018 Community Development Block Grant Program; and

**WHEREAS**, the Township of Cheltenham has executed a Cooperation Agreement with Montgomery County for conducting Community Development activities and is a participant in the Montgomery County Community Development Block Grant (CDBG) Program; and

**WHEREAS**, the Township of Cheltenham Board of Commissioners held a public meeting on April 18, 2018, to review the Community Development Block Grant Program proposal with the public and gave the Township citizenry an opportunity to review and comment on proposals as it relates to the CDBG program rules, regulations, and eligible activities promulgated by the U.S. Department of Housing and Urban Development, Community Development Block Grant Program (24 CFR Part 570); and

**WHEREAS**, it is recognized that in order to be eligible for program participation, the use of funds may be for the construction, reconstruction, rehabilitation or installation of public facilities and improvements, including but not limited to streets, curbs, sidewalks, streetscape improvements, community centers, storm drainage and sanitary sewers which directly benefits those persons which reside in a particular pre-determined low and moderate income neighborhood, as well as primarily benefiting all residents of the Township, which is one of the criteria for satisfying the national objectives of the Department of HUD under the CDBG Program; and

**WHEREAS**, Cheltenham Township Staff has recommended to the Cheltenham Township Board of Commissioners that a project removing street trees on Euston Road that have caused the sidewalk to heave and become unsafe, replacing them with street trees which are more appropriate for streetscapes, updating the ADA ramps at the intersection of Chelsea Road and Euston Road, and making select repairs to the curbs and sidewalks along Euston Road,

located in La Mott, a target low income program-eligible Census Tract 2024.02, Block Group 6, be submitted for funding under the Township’s application as part of the FY 2018 Montgomery County CDBG Program.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of Cheltenham, Montgomery County, Commonwealth of Pennsylvania, that the Township Administration be authorized to submit to the Montgomery County Department of Housing and Community Development, a CDBG funding application for FY 2018 in the amount of \$201,200.00 for certain improvements along Euston Road in La Mott, including the removal and replacement street trees, updating the ADA ramps at the intersection of Chelsea Road and Euston Road, and making select repairs to the curbs and sidewalks along Euston Road:

1)	Mobilization/Demobilization	\$10,000.00
2)	Maintenance and Protection of Traffic	\$ 5,000.00
3)	Removal of Curb and Sidewalk	\$42,000.00
4)	Removal of Street Trees	\$17,000.00
5)	Replacement of Street Trees with root barriers and tree grates	\$12,000.00
6)	Handicap ramp replacements	\$ 7,000.00
7)	E&S Controls	\$ 1,800.00
8)	Reseeding and Mulching	\$ 7,000.00
9)	Select Curb and Sidewalk Replacement along Euston	\$99,400.00
	<b>TOTAL Grant Request</b>	<b>\$201,200.00</b>
10)	<u>Engineering &amp; Inspection Fees (Township Match)</u>	<u>\$30,000.00</u>
	<b>TOTAL Project Cost</b>	<b>\$231,200.00</b>


